It would be useful to understand the likely numbers of special requests and therefore the frequency of success ie during the summer season Scotland has many visitors and data on the religious make-up of the population.

The "compassionate" category may present the greatest challenge to ensure consistency across Scotland. The examples selected focus on young people and still birth but there may be equal or more distress in other situations eg where next of kin are particularly vulnerable - an elderly spouse, recent bride or groom or a patient with mental health problems.
